## Sri Lanka third largest sourcing market for UK education sector

## Lanka to join India, Bangladesh, Nepal Tripartite Energy Grid

Sri Lanka's government has announced its priority of achieving regional energy integration by establishing grid connectivity with India by 2030, according to Power & Energy Minister Kanchana Wijesekara. The idea of regional energy integration has been under discussion for over two decades, and the government aims to follow the model of the tripartite agreement between India, Nepal, and Bangladesh to shape Sri Lanka's role in reaching agreements with other countries in the region.

The implementation of the India-Sri Lanka grid connection is seen as a significant step toward promoting energy cooperation and fostering sustainable development in the region.
